

## Search Tool

### Searching Entire Database (Volumes 1 to 15B)

**STEP 1:** To search the entire database, i.e. Volumes 1 to 15B, select **View Laws** from the menu (see Figure 1)

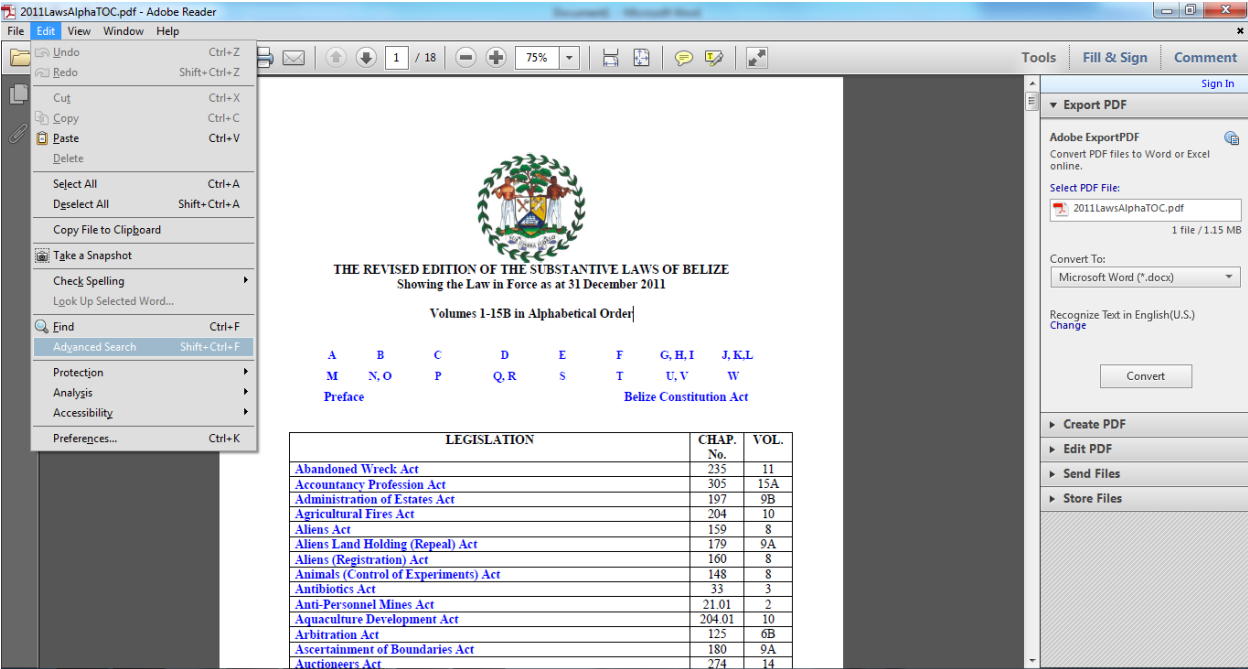
**STEP 2:** Select **Laws (Alpha)** button from menu (see Figure 2).

**NOTE:** Advanced search can also be performed using the **Alphabetical**, **Subject Title** and **Preliminary Booklet** options.

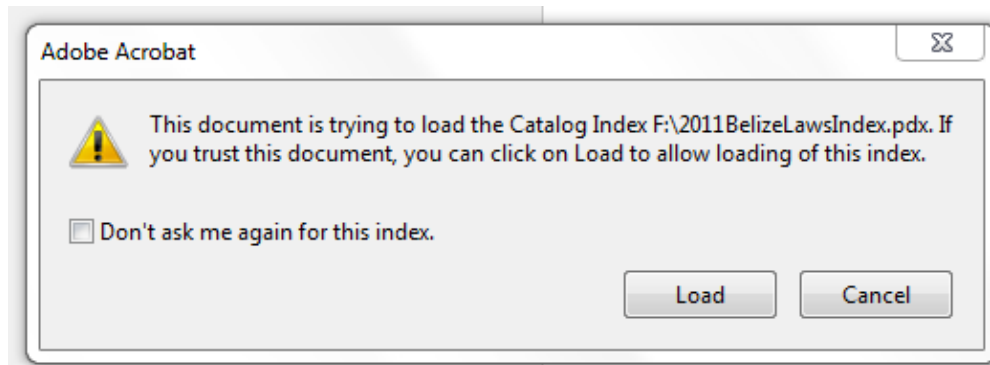
**STEP 3:** Select "Edit" > "Advanced Search" from the Menu as shown in Figure 3.

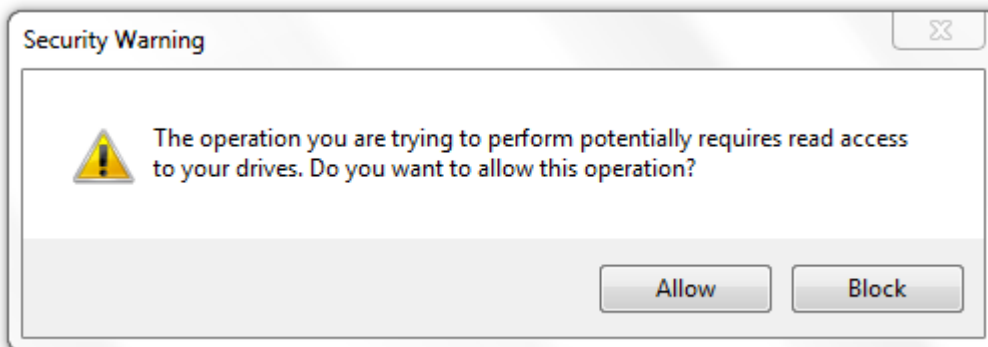
A dialogue box as seen in Figure 4 below will appear:

- 1) Check “Don’t ask me again for this index”; and
- 2) Click the button “Load”.

Click the “Allow” button.

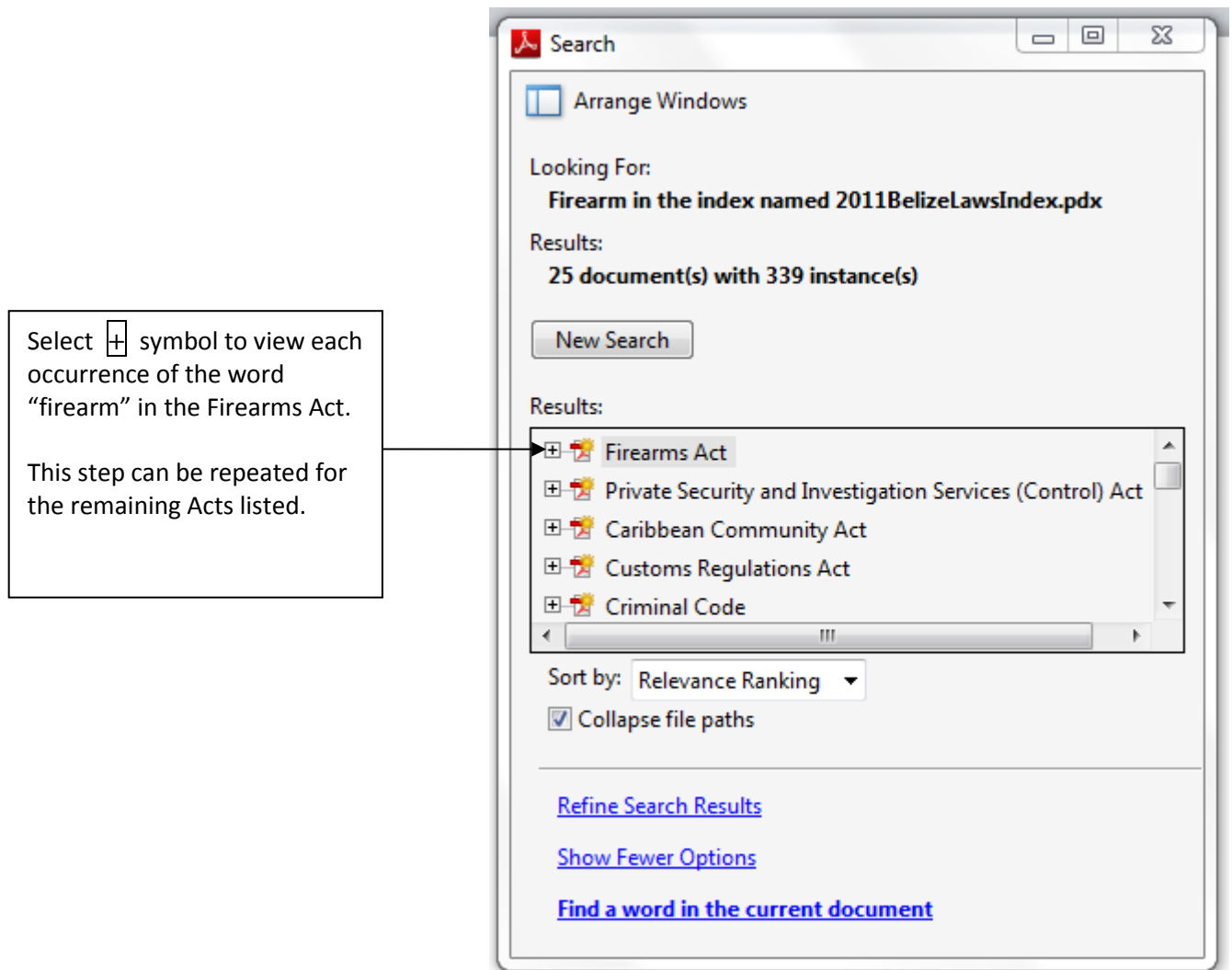
**Figure 6b**

The Adobe Acrobat Search column will appear in a separate window as shown in Figures 6a and 6b below.

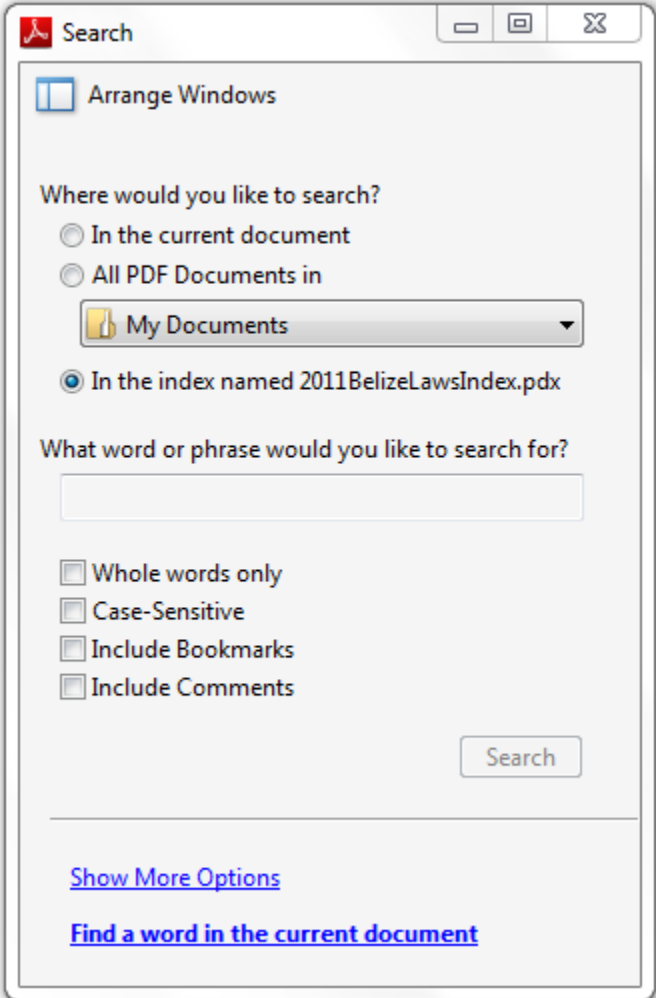
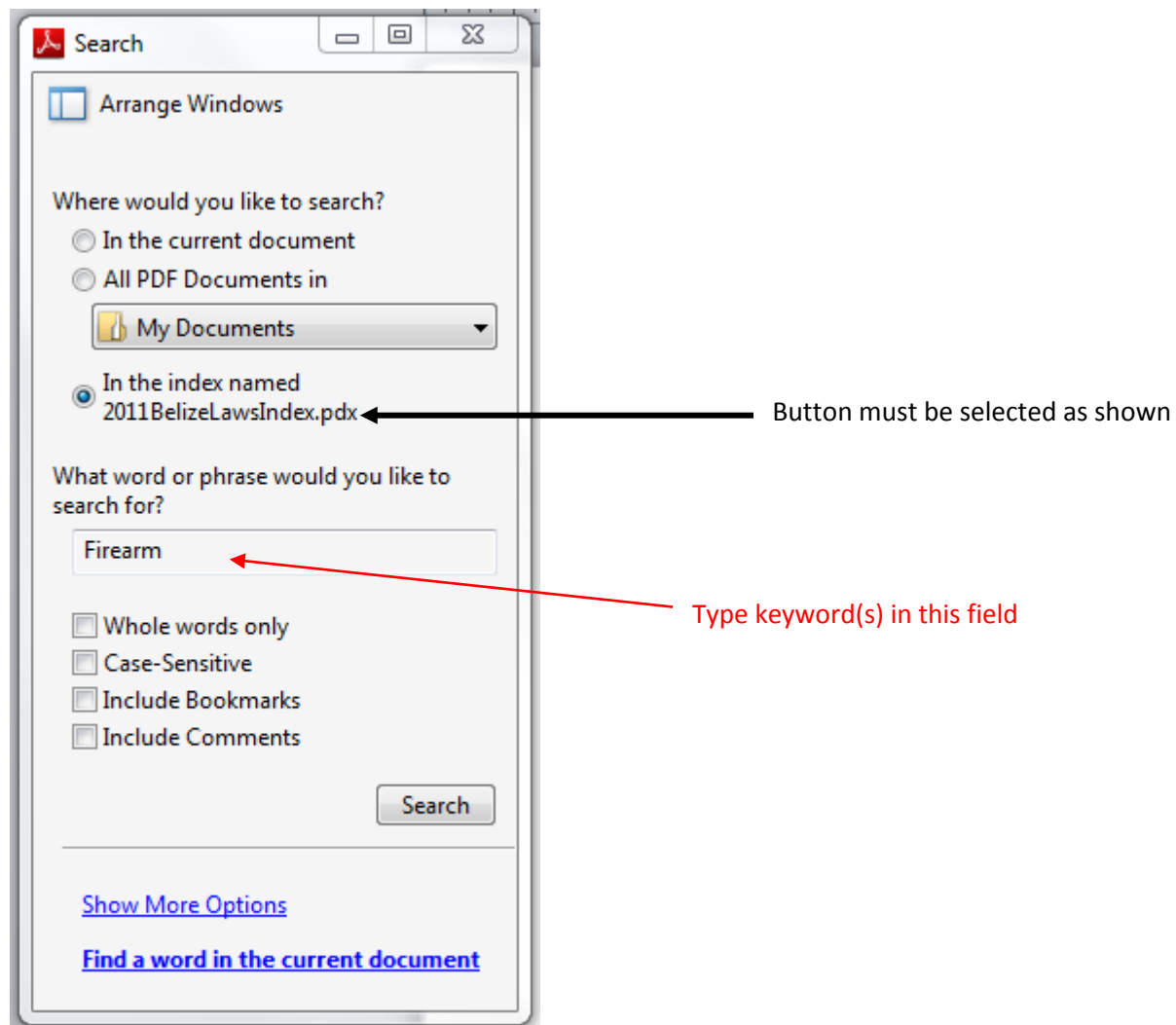

**STEP 4:**


- a) Type in keyword(s) within the *What word or phrase would you like to search for?* field;
- b) Under *Where would you like to search?* heading, select the button “ **In the index named 2011BelizeLawsIndex.pdx**” (as shown the in Figure 6b above); and
- c) Click on the Search button. (This will activate a Search Result window as shown in Figure 7).

**NOTE:** The **2011BelizeLawsIndex.pdx** file is a special index which consists of a collection of keywords extracted from the entire Laws of Belize database. When this index is selected the entire database i.e. Volumes 1 to 15B, can be quickly searched.

**STEP 5:** To view search results, select any of the items listed in the “**Results:**” window as shown in Figure 7. The keyword would appear highlighted within the document.




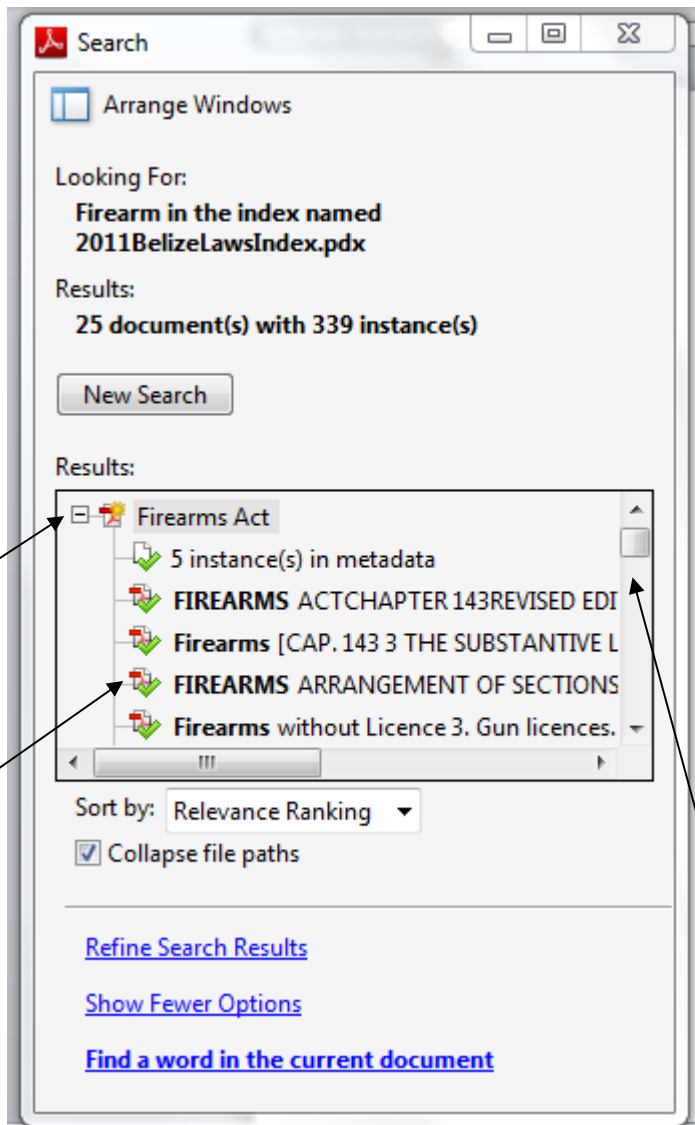

Shown above is an example of a search for the keyword “firearm”. The twenty-five (25) documents listed contained the keyword firearm. You can review each occurrence of the word by expanding the plus symbol  next to each Act as seen in Figure 7.

To continue searching for similar occurrences of the keyword in another document, select any of the other Acts listed in the “Results:” window.

Select  symbol to hide each occurrence of the word "firearm" in the Firearms Act.

Select any  icon to navigate to the "firearm" reference within the Firearms Act.



Use the scroll bar to view other occurrence of the word "firearm" in the Act.

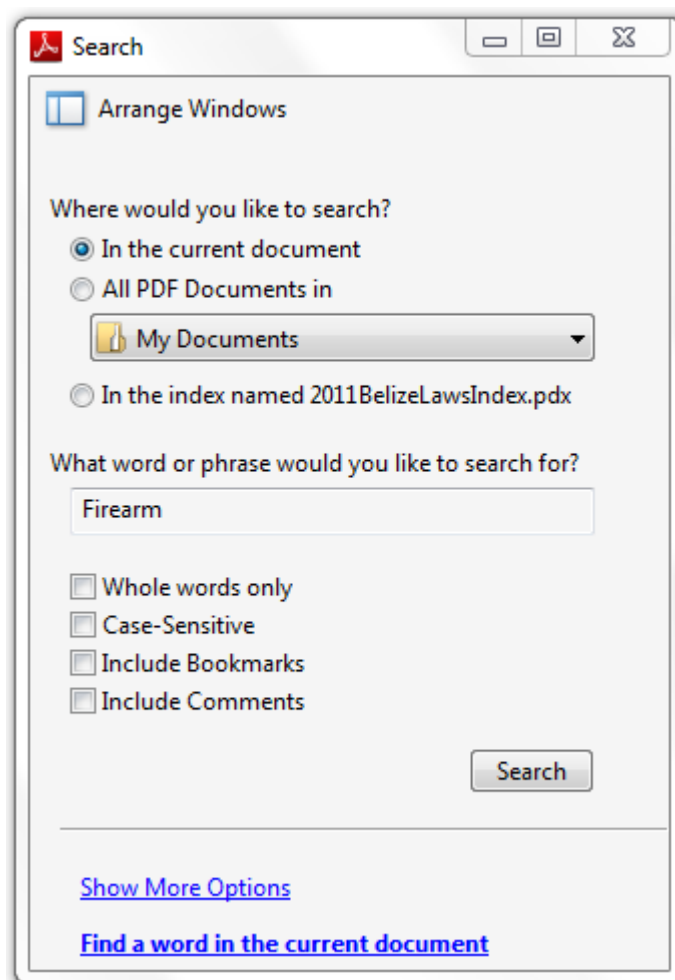

## Searching current document

To search for a specific word in a particular file—

- 1) Open the document you would like to search;
- 2) Select "Edit" > "Advanced Search" from the Menu (as shown in Figure 3);
- 3) Type in keyword(s) within the *What word or phrase would you like to search for?* field;
- 4) Under *Where would you like to search?* Heading, select the button " **In the current document**"; and
- 5) Click on the Search button as shown in Figure 9 below.
