- (4) An inspector may take samples of articles to which this Act and the regulations apply and submit such samples to an analyst for examination or analysis without paying compensation to the owner.

- (5) In the case of persons appointed to the Board, other than officers appointed under subparagraph (1)(b), (c), (d) and (e), if a member or his alternate fails to attend three consecutive meetings without good cause, he shall vacate his position on the Board and the Minister shall consider an appointment from another organisation.
- **2.** The appointment of a member shall, subject to the provisions of this Schedule, be for a period not exceeding two years and such member shall be eligible for reappointment.
- **3.** The Minister shall appoint one of the members to be Chairperson thereof.
- **4.** If the Chairperson is unable to act, the Minister may appoint any member to act in the place of the Chairperson.
- **5.**–(1) Any member other than the Chairperson may at any time resign his office by instrument in writing addressed to the Minister and transmitted through the Chairperson and from the date of receipt by the Minister of such instrument that member shall cease to be a member of the Board.
- (2) The Chairperson may at any time resign his office by instrument in writing addressed to the Minister and such resignation shall take effect as from the date of receipt by the Minister of that instrument.
- **6.** The Registrar shall be appointed by the Board, subject to approval by the Minister.
- 7. If any vacancy occurs in the membership such vacancy shall be filled by the appointment of another member by the Minister, and in making such appointment, the Minister shall have regard to the provisions of paragraph 1.

- **8.** The names of all members as first constituted and every change in the membership shall be published in the *Gazette*.
- **9.** The Board may co-opt such persons, whether Government officers or otherwise, to attend particular meetings or parts thereof, as it thinks fit.
- **10.** The funds of the Board shall consist of such monies as may from time to time be placed at its disposition for the purposes of this Act by the National Assembly, and such other monies as may be lawfully paid to the Board.
- 11. The Board shall keep proper accounts of its receipts, payments, assets and liabilities, and such accounts shall be audited annually by the Auditor-General.

- each financial year, cause to be made and transmitted to the Minister a report of its activities during the preceding financial year, including a statement of its accounts, audited in accordance with paragraph 11, and the Minister shall cause copies of such report, together with the auditor's report, to be laid on the Tables of the House of Representatives and of the Senate.
- (2) The Board shall, before the date specified by the Minister, submit to the Minister for his approval estimates of revenue and expenditure for the ensuing financial year.
- 13.–(1) The seal of the Board shall be kept in the custody of the Chairperson or the Secretary and shall be affixed to instruments pursuant to a resolution of the Board in the presence of the Chairperson or any other member acting in that capacity and the Secretary.
- (2) The seal of the Board shall be authenticated by the signatures of the Chairperson, or any other member authorized to act in that behalf, and the Secretary.
- (3) All documents other than those required by law to be under seal made by and all decisions of the Board may be signified under the hand

of the Chairperson, or any other member authorized in that behalf, or the Secretary.

- **14.**–(1) The Board shall meet at such times as may be expedient for the transaction of its business and such meetings shall be held at such places and times and on such days as the Board may determine.
- (2) The Chairperson or any member acting in that capacity shall preside at all meetings of the Board.
- (3) The Chairperson may at any time call a special meeting of the Board and shall call a special meeting within seven days of the receipt of a written requisition for that purpose addressed to him by any three members of the Board.
 - (4) A quorum of the Board shall be eight.
 - (5) Minutes in proper form of each meeting of the Board shall be kept.
- (6) The validity of the proceedings of the Board shall not be affected by any vacancy amongst the members thereof.
- 15.-(1) The Board may appoint such committees as it thinks fit, and may delegate to any committee so appointed the power and authority to carry out on its behalf such functions as the Board may determine, so that, however, no committee so appointed shall have the power to make regulations.
- (2) The constitution of any committee appointed pursuant to subparagraph (1) shall be determined by the Board.
- (3) The validity of the proceedings of a committee appointed pursuant to this paragraph shall not be affected by any vacancy amongst the members thereof.
- 16.-(1) No member of the Board shall be personally liable for any act or default of the Board done or omitted to be done in good faith in the course of the operations of the Board.
