- (b) Any person who contravenes the provisions of subsection (2) (a) commits an offence of this section, and is liable on summary conviction to a fine of five hundred dollars or to imprisonment for twelve months, or to both such fine and imprisonment.
- (3) The Minister of the appropriate Ministry may by any regulations make provisions generally for the use of the emblem and the prevention and repression of its misuse.
- 9.–(1) The highest authority of the Society shall be a General Assembly constituted in accordance with its Constitution made under this Act.

There shall also be a Central Committee and District Committees with such powers and duties as may be prescribed by the said Constitution.

- (2) The first members of the General Assembly shall be those persons who, immediately before the coming into operation of this Act,
- **10.**–(1) The General Assembly shall frame and establish a Constitution being rules for the management of the affairs of the Society and the accomplishment of its objects. Such Constitution shall provide, inter alia,
