1. This Act may be cited as the Registration of Nursing Homes Act.

2.–(1) In this Act, unless the context otherwise requires,

"CARICOM Member State" means a State which is a party to the Treaty of Chaguaramas establishing the Caribbean Community including the

CARICOM Single Market and Economy; "Council" means the Medical Council of Belize established under section

3 of the Medical Practitioners Registration Act, Cap. 39; "maternity home" means any premises used or intended to be used for the

"medical institutions" has the same meaning as in section 2 of the Medical Services and Institutions Act:

"medical practitioner" has the same meaning as in section 12 of the Medical Practitioners Registration Act, Cap. 318;

"nursing home" means any premises used or intended to be used, for the reception of, and the providing of nursing for, persons suffering from any sickness, injury or infirmity and includes a maternity home, but does not include medical institutions:

"pupil midwife" means a person who is undergoing training for the purpose of becoming a certified midwife, and for that purpose is attending women in childbirth as a part of a course of practical instruction in midwifery recognised by the Council;

"Register" means the Register of Nursing Homes kept by the Registrar General under the provisions of this Act;

"registered midwife" means a person registered in the general part of the register, containing the names of all midwives, required to be kept under the Nurses and Midwives Registration Act, Cap. 321;

"registered nurse" means a person registered in the general part of the register, containing the names of all male and female nurses, required to be kept under the Nurses and Midwives Registration Act, Cap. 321.

- (2) Reference to the general part of the register in this definition shall include references to other parts of the said register in relation to any premises used or intended to be used solely for the reception of, and the provision of nursing for, a class of patients in whose case the requisite nursing can be suitably and adequately provided by nurses of a class whose names are contained in some part of the said register.

- (3) Every application for registration shall be accompanied by a fee of twenty-five dollars which shall be paid into the Consolidated Revenue Fund.
- **4.–**(1) Subject to this Act, the Council may, on the receipt of an application for registration, approve of the registration of the applicant in respect of the nursing home named in the application.
- (2) The Council may, by order, refuse to approve of the registration of the applicant, if they are satisfied,

- **5.**–(1) The Registrar General shall keep a Register of Nursing Homes in such form as shall be prescribed by the Director of Health Services.
- (2) The Council shall from time to time inform the Registrar General in writing of all applications for registration approved by it, and the Registrar General shall, upon the receipt of such information, register the applicant in respect of the nursing home named in the application, and issue to him a certificate of registration.

- give to the applicant or to the person registered, as the case may be, not less than fourteen days' notice of its intention to make such an order, and every such notice shall state the grounds on which the Council intends to make the order, and such notice shall contain an intimation that, if within fourteen days after the receipt of the notice the applicant or the person registered informs the Council in writing that he desires to do so, the Council will before making the order give him an opportunity of being heard on the matter either in person or by a representative, why the order should not be made.
