Short title. 1. This Act may be cited as the Seventh Day Reform Movement Inc., Act.

Interpretation. 2. In this Act, unless the context otherwise requires,

"Church" means the Seventh Day Reform Movement, Inc.;

"Corporation" means the corporation by the name of the Seventh Day Reform Movement Inc., constituted under section 3 of this Act;
