# GOSPEL OF THE KINGDOM MINISTRIES .

1. This Act may be cited as the Gospel of the Kingdom Ministries Act.

[29th April, 2000]

2. In this Act, unless the context otherwise requires,

"Church" or "Corporation" means the Gospel of the Kingdom Ministries constituted under section 3 of this Act;

"property" means property of every description, real or personal, movable or immovable

3. The Gospel of the Kingdom Ministries is hereby constituted a body corporate with perpetual succession and a common seal which may from time to time be altered, and it may by its corporate name sue or be sued.
