 1. This Act may be cited as the Exalting Jesus Christ Ministries Act.

 Interpretation.

 2. In this Act, unless the context otherwise requires,
- "Church" or "Corporation" means the Exalting Jesus Christ Ministries constituted under section 3 of this Act;

 "Property" means property of every description, real or personal,
