Short title.	1. This Act may be cited as the Iglesia Evangelica Pentecostes Los Redimidos Por Jesucristo Act.	
Interpretation.	2. In this Act, unless the context otherwise requires,	
	"Corporation" means the corporation by the name of Iglesia Evangelica Pentecostes Los Redimidos Por Jesucristo constituted under this Act; "property" means property of every description, whether real or personal, movable or immovable.	
Membership of the Corporation.	3. –(1) The President of the Corporation for the time being, the members of the Governing Board of the Council for the time being and their successors office as such President, and such members shall be constituted a Corporation by the name of style of "Iglesia Evangelica Pentecostes Los Redimidos Peresucristo".

6. The Corporation shall have full powers,

Capacity of the Corporation.

- (a) to acquire and hold by purchase, devise or otherwise, property within Belize, and to convey, assign, demise or otherwise dispose of such property;
- (b) to borrow and take up at interest any sum or sums of money for the purpose of erecting or improving the Iglesia Evangelica Pentecostes Los Redimidos Por Jesucristo, schools, manses, dwelling-house or other buildings, and for that purpose to mortgage by deed under the said seal such portions of its property as may be necessary for securing the repayment of such moneys, with interest thereon;
- (c) to take, hold, control, improve, manage, employ and invest all such property as may be deemed advisable, but only for the purposes of the Corporation;
- (d) organize, maintain, carry on, foster, promote and contribute to the support of the Iglesia Evangelica Pentecostes Los Redimidos Por Jesuscristo, missions, schools, publication and Iglesia Evangelica Pentecostes Los Redimidos Por Jesucristo worship; and
- (e) do all other things deemed necessary, convenient or expedient to the accomplishment of any and all of the powers aforesaid.

7. All property belonging to the Iglesia Evangelica Pentecostes Los Redimidos Por Jesucristo shall be vested the Corporation.

8. In conducting its doctrines and conducting its affairs, the Iglesia Evangelica Pentecostes Los Redimidos Por Jesucristo shall obey the Belize Constitution, Cap. 4 and the laws of Belize.

9. The Corporation shall have the power to make by- laws and to alter the same for their own internal management and control, and such by-laws shall be binding on every member thereof.
