(b) knowingly aids in the engagement of any person so induced by forwarding or conveying him or by advancing money or in any other way whatever,

commits an offence and is liable on conviction, on indictment to imprisonment, for any term not exceeding two years, or to a fine to such amount as the court thinks fit, or to both fine and term of imprisonment.
