- (3) Any person who in any manner encourages, aids or assists at the fighting or baiting of any such animal shall be liable to a fine not exceeding one hundred dollars for every such offence.
- **4.**–(1) Every person who impounds or confines or causes to be impounded
- or confined in any pound or receptacle of a like nature, whether public or private, any animal, shall provide and supply during such confinement a sufficient quantity of fit and wholesome food and water to that animal.
- (2) Any such person who refuses or neglects to provide and supply that animal with such food and water as is required by this section, shall for every offence forfeit and pay a penalty of ten dollars.

5.–(1) In case any animal is at any time impounded or confined as

mentioned in section 4 (1) of this Act and continues confined without fit

and sufficient food and water for more than twelve successive hours, any

person may from time to time and as often as is necessary enter into and upon any pound, whether public or private, or other receptacle of a like nature in which any such animal is so confined, and supply such animal

- with fit and sufficient food and water during so long a time as such animal remains and continues confined as aforesaid, without being liable to any action of trespass or other proceeding by any person who impounded or confined the animal.
