6. Nothing contained in sections 3 and 5, shall prevent any person from wearing any uniform or dress, mentioned in sections 3 and 5, in the course of a stage play performed in a place duly licensed or authorised for the public performance of stage plays, or in the course of a music hall or circus performance, or in the course of any bona fide military representation.

7. Every person who contravenes section 3 or 5 shall be guilty of an offence and liable on summary conviction to a fine not exceeding one hundred dollars.
